### **Objectives and Investment Policy**

The Fund's objective is to provide investors with long-term capital growth.


The Fund aims to achieve its objective by investing in global equity and equity-related securities. The Fund will gain exposure primarily through direct investment in these securities but may also invest indirectly in such securities by investing (up to 10% of its net assets) in collective investment schemes.

The Fund may invest up to 100% of its Net Asset Value in equities and equity-related securities comprising common stock, preference and convertible preference shares, as well as depository receipts for such securities, which equities and equity-related securities will be listed or traded on Recognised Exchanges worldwide.

In selecting investments for the Fund, the Investment Manager employs a quantitative screening process to rank companies in the Benchmark (as defined below) each quarter, based on their efficient use of capital, ability to generate cash, the quality of their earnings and balance sheet strength.

The Fund may invest up to 20% of its net assets in cash or ancillary liquid assets comprising short term money market instruments, including, but not limited to, non-bespoke fixed or floating rate notes and fixed or variable rate commercial paper (such as fixed and floating rate bonds), which will be listed on a Recognised Exchange, and cash equivalents such as certificates of deposit and cash deposits denominated in such currency or currencies as the Investment Manager shall determine. Any debt securities held as ancillary liquid assets may be corporate or government issued and will have a credit rating or an implied credit rating of "investment grade" at the time of investment.

### Risk and Reward Profile of the Fund



The risk indicator is determined using historical data or, where historical data is not available, using simulated historical data. Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the Fund. The risk category shown is not a target or a guarantee and may change over time. A category 1 fund is not risk free, the risk of loss is small but the chance of making gains may also be limited. With a category 7 fund, the risk of losing money is high but so also is the possibility of making gains. The risk indicator for the Fund is set at 6 as this reflects the market risk arising from proposed investments.

Investments will have a global focus insofar as investments are not confined or concentrated in any particular geographic region or market. The Fund may have exposure of up to 15% of its Net Asset Value to emerging markets.

The Fund's performance is measured against the MSCI World Net Total Return Index (the "Benchmark"). The Benchmark is a free floatadjusted market capitalization weighted index that is designed to measure the equity market performance of large- and mid-cap stocks across 23 developed market countries.

The Fund is actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. Whilst the Benchmark is used as an initial indicative universe from which to select stocks, the Investment Manager has broad discretion with respect to individual stock selection and may invest in securities that are not included in the Benchmark.

Any income arising from the Fund will be reinvested and it is not intended that the Fund will pay dividends.

You may buy and sell shares in the Fund on each Business Day in Ireland.
