Objectives and Investment Policy

The Fund's primary investment objective is to outperform the MSCI All Country World Index (net of fees) (the "Benchmark").

In pursuit of its investment objective, the Fund will invest up to 100% of the Net Asset Value in a diversified portfolio of global equity and equity-related securities (including common stock, preference and convertible preference shares, American depositary receipts and global depositary receipts, equity linked notes, convertible bonds and rights), which are listed on a Recognised Exchange worldwide. The Fund may invest in China A shares listed on the Shanghai Stock Exchange via the Shanghai Hong Kong Stock Connect scheme, or the Shenzhen Stock Exchange via the Shenzhen Hong Kong Stock Connect scheme.

The Fund may invest up to 10% of its Net Asset Value in the units and/or shares of collective investment schemes, including money market funds and ETFs (which are eligible for investment by a UCITS) in accordance with the requirements of the Central Bank. The Fund can also hold up to 20% of Net Asset Value in cash (including in currencies other than the Base Currency) or ancillary liquid assets comprising short term money market instruments (including fixed / floating rate notes, commercial paper, US treasury issues and fixed income debt securities, which will be listed on a Recognised Exchange) and cash equivalents (such as certificates of deposit and cash deposits) for cash management purposes.

Investments will have a global focus and are not confined or concentrated in any particular geographic region or market.

The Fund may utilise financial derivative instruments (futures, options, forwards and swaps) for efficient portfolio management purposes including for hedging. Derivatives may be traded on a Recognised Exchange or over-the-counter.

The Fund is actively managed in reference to the Benchmark by virtue of the fact that it seeks to out-perform the Benchmark and uses the Benchmark for performance measurement / comparison purposes. While it is anticipated that the strategy will be adequately diversified

across stocks, sectors, countries and regions, a significant portion of the Fund's securities will be components of the Benchmark but will likely have different weightings from the Benchmark. The Investment Manager may use its discretion to invest in securities or sectors not included in the Benchmark in order to take advantage of investment opportunities. The investment strategy does not restrict the extent to which the Fund's holdings may deviate from the Benchmark. Deviations from the Benchmark are not limited by any tracking error and may be significant. This is likely to increase the extent to which the Fund can outperform (or underperform) the Benchmark.

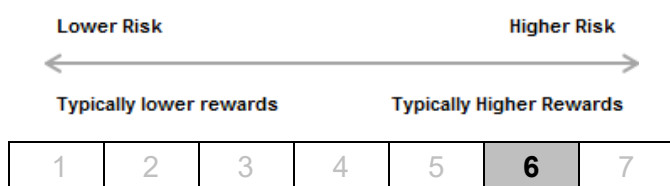
This Share Class will not pay a dividend. Any income arising from the Fund will be reinvested to grow the value of your investment.

You may buy and sell shares in the Fund on each business day in Ireland on which banks in Ireland are open for business.

Risk and Reward Profile of the Fund

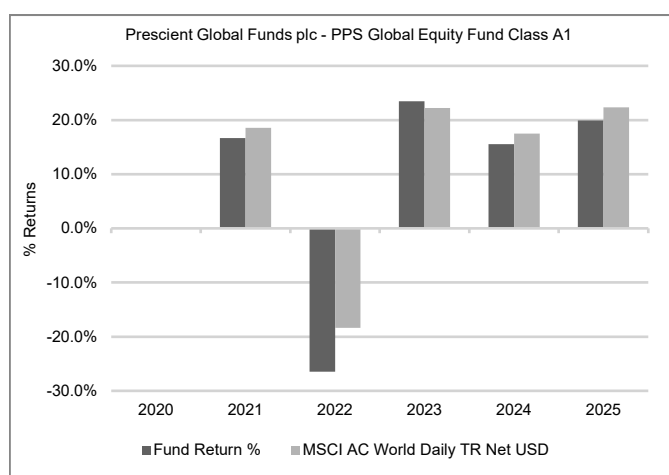
