Objectives and Investment Policy

The Fund's investment objective is to maximise capital growth by investment directly or indirectly (through investment in collective investment schemes) in Chinese equities and equity-related securities.

Chinese equities and equity-related securities may include China A Shares, China B Shares, China H Shares, China Red Chip Shares, American Deposit Receipts as well as Chinese concept stocks, convertible bonds, or participatory notes. The Fund intends to invest directly or indirectly in China A shares through the Shanghai Hong Kong Stock Connect scheme, or the Shenzhen Hong Kong Stock Connect scheme and may also gain exposure to the China A Share market through the "Qualified Foreign Investor" (QFI) regime.

The Fund may invest up to 100% of the Net Asset Value of the Fund in collective investment schemes (including money market funds and exchange traded funds), which are managed by discretionary portfolio management companies who specialise in Chinese equities and equity-related securities, where such portfolio management companies are recognised and regulated, and meet the due diligence requirements of the Investment Manager.

The Fund may invest up to 15% of net assets in Participation notes ("Pnotes") notes issued by qualifying foreign institutions that have been approved as a QFI to obtain exposure to the Chinese market.

The Fund may also hold or invest in deposits, Government debt securities and money market instruments in certain circumstances, such as where market conditions may require a defensive investment strategy, the holding of cash on deposit pending reinvestment, in order to meet redemptions and payment of expenses or in order to support derivative exposure or in any other extraordinary market circumstances, which in the reasonable opinion of the Investment Manager would be likely to have a significant detrimental effect on the performance of the Fund. Up to 100% of the net assets of the Fund may be invested in deposits / ancillary liquid assets at any time.

The risk indicator is determined using historical data or, where historical data is not available, using simulated historical data. The Fund may use financial derivative instruments for efficient portfolio management (including for hedging purposes) to reduce portfolio, equity or other asset class risks and/or to reduce costs in the Fund, subject to the conditions and within the limits from time to time laid down by the Central Bank. The financial derivative instruments and techniques which may be used by the Fund are futures and swaps (index swaps and total return swaps).

The Fund is considered to be actively managed in reference to the MSCI China All Shares Index (the "Benchmark") (which captures the performance of large and mid-cap Chinese securities across China Ashares, B-shares, H-shares, Red Chips, P-chips and foreign listings) by virtue of the fact that it uses the Benchmark for performance comparison purposes and for calculation of performance fees. However, the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

This Share Class will not pay a dividend. Any income arising from the Fund will be reinvested to grow the value of your investment.

The Fund is suitable for investors seeking capital growth of their investment with a high-risk tolerance and with an investment horizon of three years or longer.

You may buy and sell shares in the Fund on each business day in Ireland on which banks in Ireland are open for business.
