This Fund is managed by Prescient Fund Services (Ireland) Limited (the "Manager")

Objectives and Investment Policy

The Fund's objective is to generate capital growth and income over the long term.

The objective is achieved mainly through investing in global equities and fixed income securities. Such exposure will primarily be taken indirectly through investment in collective investment schemes, which are eligible for investment by the Fund in accordance with Central Bank requirements. The Fund will invest a minimum of 50%, and may invest up to 100% of net assets, in open ended collective investment schemes in order to gain exposure to such global equities and fixed income securities.

The Fund will seek on an annual basis to outperform on a combined basis 60% of the MSCI AC World TR Index and 40% of the Barclays Global Aggregate Index (the "Combined Benchmark").

Exposure to equities may be taken directly or indirectly via collective investment schemes (subject to a limit of 50% in the case of direct equity investments). Equity and equity related securities to which the Fund may have exposure include, but are not limited to, preferred stocks and depository receipts (American Depositary Receipts and Global Depositary Receipts) for such securities, which are listed or traded on recognised exchanges in the United States, the United Kingdom, developed European and developed Asian markets.

The Fund may invest up to 60% of net assets (indirectly via collective investment schemes) in debt and debt-related securities (including emerging market sovereign and corporate debt, government bonds and/or corporate bonds which may have fixed or floating rates of interest and 90% of which will have a credit rating of investment grade or higher by Standard and Poor's, Moody's Investors Service or Fitch Ratings Ltd.) listed or traded on a recognised exchange.

Where market conditions require a defensive strategy or pending reinvestment, the Fund may also hold ancillary liquid assets including

cash, short-term debt securities and money market instruments (such as treasury bills and certificates of deposit) issued by governments or corporations, which have a credit rating or an implied credit rating of "investment grade" at the time of investment by Standard & Poors, Moody's or Fitch Ratings Limited.

The Fund may use financial derivative instruments (in particular, currency forward contracts) for efficient portfolio management purposes (including hedging purposes), subject to the conditions and within the limits laid down by the Central Bank.

The Fund is considered to be actively managed in reference to the Combined Benchmark by virtue of the fact that it seeks to outperform the Combined Benchmark.

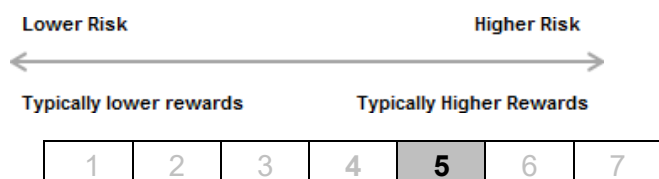
Any income arising from the Fund will be reinvested and it is not intended that the Fund will pay dividends.

The Fund is suitable for investors who have a medium risk profile and who wish to capture capital growth and income over the long term. It is suitable for investors with at least a basic knowledge of and / or experience with financial products and that can bear financial losses (up to the total loss of the invested amount) and attach no importance to capital guarantees.

You may buy and sell shares in the Fund on each Business Day in Ireland.

Risk and Reward Profile of the Fund



The risk indicator is determined using historical data or, where historical data is not available, using simulated historical data. With a category 7 fund, the risk of losing money is high but so also is the possibility of making gains. **The risk indicator for the Fund is set at 4 as this reflects the market risk arising from proposed investments.**

The Fund does not offer any capital guarantee or assurance that the investor will receive a fixed amount when redeeming.

In addition to the risk captured by the indicator, the overall Fund value may be considerably affected by:

- **Country Risk** - The value of the Fund's assets may be affected by uncertainties such as changes in a country's government policies, taxation, restrictions on foreign investment, currency

decisions, applicable laws and regulations, together with any natural disasters or political upheaval, which could weaken a country's securities markets.

- **Emerging Market Risk** – Investing in emerging market securities involves a higher degree of risk. Such risks may include but are not limited to political, economic and social instability, small market sizes with limited liquidity and less developed legal structures.
- **Currency Risk** - the Fund may be exposed to currency risk in relation the valuation of assets held in currencies other than its base currency.
- **Stock Market Risk** – the Fund is subject to stock market risk, which is the chance that stock prices overall, will decline. Stock markets tend to move in cycles, with periods of rising prices and periods of falling prices.
- **Investment in Collective Investment Schemes Risk** – the value of the Fund's shares will be linked to the performance of the underlying schemes and any delay, suspension or inaccuracy in the calculation of the NAV of an underlying scheme will directly impact the calculation of the NAV of the Fund. The risks associated with investing in the Fund may be closely related to the risks to which the underlying schemes are exposed.

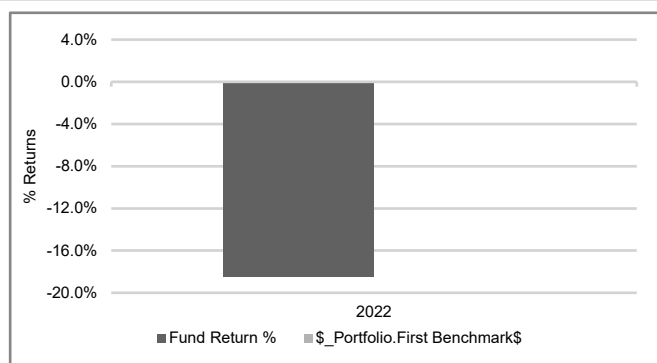
