INVESTMENT AND RETURN OBJECTIVE

The Fund aims to generate real returns in US Dollars and is benchmarked to the US inflation rate.

INVESTMENT PROCESS

The investment universe includes fixed, floating, real and nominal money market and bond market investments, property, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.

WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally. This Fund is suitable to investors with a medium to long-term investment horizon.

RISK INDICATOR DEFINITION

This portfolio typically has no equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses in USD terms over the shorter term unlikely. This portfolio typically targets a return in the region of 1% - 3% above US inflation over the long term.



FUND COMMENTARY

March was an eventful month for markets and specifically for SA fixed income markets as we saw the collapse of Silicon Valley Bank, the buying of Credit Suisse, the Fed hiking 25pts with market participants now expecting the next move to be lower and the SARB surprising with a 50bps hike. The Fund took its duration exposure mainly in the SOAF24 bonds. These were unchanged post the decision by the SARB and held onto its gains for the month. This contributed to the Fund returning 0.52% gross of fees for the month of March. A pleasing outcome given the massive amounts of uncertainty that global markets are dealing with.

The South African inflation print for February came in slightly higher than expected at 7% year-on-year, though still lower than the peak of 7.8% in July 2022. Shorter term inflationary pressures saw the SARB hike interest rates by 50bps at the March MPC meeting. The move did not impact the bond yields with the ALBI seeing a strong March, more specifically the shorter to the belly part of the curve. We will keep the current duration in the Fund as the curve still shows value.

We see the Fund being favorably positioned given the attractive yield built into the Fund given the risk focused signature we have maintained.

Contributors to Performance:

The main driver of performance for March was the duration position in the Fund, helped also by the higher yielding assets in the Fund.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
