INVESTMENT AND RETURN OBJECTIVE

The Fund aims to outperform US CPI in USD terms over time while aiming to limit capital losses.

INVESTMENT PROCESS

The Fund invests in money market instruments, capital market instruments and equities with an active asset allocation overlay. The equity component of the Fund is always protected. The Fund is available in Euro, US dollars, Sterling and Rand where the currency risk is hedged back to the pricing currency to reduce currency volatility.

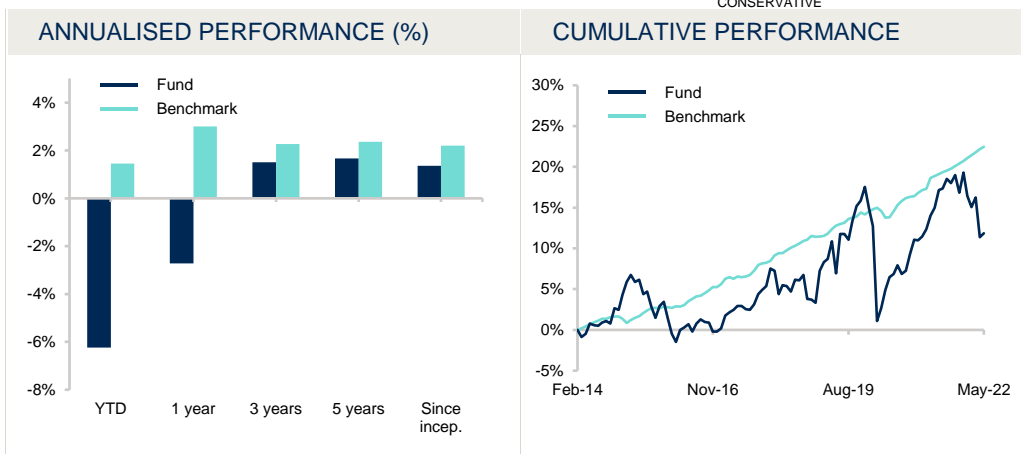
WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to a risk aware asset allocation offshore fund. This Fund is suitable to investors with a medium to long-term investment horizon.

RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.

FUND COMMENTARY

U.S. CPI jumped 8.3% in April from a year ago, surpassing the 8.1% estimate to remain near the 40-year highs. Shelter costs, which comprise about one-third of the CPI, accelerated at its fastest pace since 1991. The U.S. Federal Reserve will begin the first phase of its balance sheet reduction program this month. The central bank will no longer reinvest proceeds of up to \$30 billion in maturing Treasury securities and up to \$17.5 billion in maturing agency mortgage-backed securities per month. Thus, allowing a potential monthly amount of \$47.5 billion to roll-off the balance sheet. From September, these caps will increase to \$60 billion and \$35 billion, respectively, for a potential monthly reduction amount of \$95 billion.

Across the Atlantic, the European Central Bank President Christine Lagarde said officials won't rush into withdrawing stimulus. Lagarde published a blog post essentially laying out a path for the ECB's next three scheduled decisions that will put the institution on course to finally exit 'sub-zero' monetary policy and align more with developed market peers who have already taken policy action against rising inflation. The ECB will likely hike once in July and September, bringing its deposit rate from -0.5% up to zero.

Global equity markets ended the month of May mixed, with most indices clawing back intramonth losses. Of the major indices, the S&P500 and MSCI World Index ended higher, while the MSCI Emerging Market index struggled to keep up the pace. Global bonds seemed to have stabilized after a tough start to the year. The Bloomberg Global Aggregate Index gained 1.0%. After a strong start to the year, the rally on the U.S. dollar cooled. The Bloomberg Dollar Spot Index, which tracks the performance of the U.S. Dollar against a basket of 10 leading global currencies, lost 1.5% during May. On the oil front, Brent crude climbed above \$120/bbl on news that EU leaders had imposed a partial ban on Russian oil to deny Russia of further revenue to fund its war in Ukraine. After a volatile May, the S&P500 index closed flat (+0.2%), as did the MSCI Developed Market index (+0.1%), and the MSCI Emerging Market index (0.1%). Both the HSCEI (+1.7%) and the Nikkei (+1.6%) have bounced off the lows.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.
